



MAYOR & COUNCIL
REGULAR BUSINESS MEETING MINUTES

July 9, 2020

Mayor Jacobs called the meeting to order at 6:04 p.m. In attendance were Vice Mayor Andrews, Councilmember Jones, Councilmember Edwards, Councilmember Collyer, Town Manager Resele, Clerk-Treasurer Loller, and Police Chief Dempsey.

Agenda

Vice Mayor Andrews made a motion to approve the agenda as amended. Councilmember Jones seconded the motion. All in favor. Motion carried.

Minutes

Vice Mayor Andrews made a motion to approve the Regular Business Meeting minutes for May 28, 2020. Councilmember Collyer seconded the motion. All in Favor. Motion carried.

Vice Mayor Andrews made a motion to approve the Regular Business Meeting minutes for June 11, 2020. Councilmember Jones seconded the motion. All in Favor. Motion carried.

Vice Mayor Andrews made a motion to approve the Closed Session Meeting minutes from June 11, 2020. Councilmember Collyer seconded the motion. All in favor. Motion carried.

Special Recognition

Denny Dalrymple – Mayor Jacobs read the following:

“The Mayor and Council of the Town of Rock Hall hereby presents this certificate of achievement and sincere appreciation to Denny Dalrymple on the occasion of his retirement on June 30, 2020. His extraordinary dedication as Operator of the Town’s Wastewater Treatment plant, for the past 18 years, to protect the Town and the Chesapeake Bay from the potentially serious consequences of improper plant operation and output are to be specially commended. A grateful Town wishes him lots of time to enjoy life with less worry and good health.”

Mayor Jacobs also wanted that thank Taylor Walker from the Public Works Department for his help over the July 4th weekend with the well issue.

COVID-19 Challenge

Bill Webb from the Kent County Health Department said the state is doing well and the new focus is trying to get the school and college reopened. 15% of Kent Counties population has been tested which is the 2nd highest percent in the State. Kent County positively rate is 1.8% and the State is at 4.6%. The testing facility is now open next to LabCorp in Chestertown, Monday through Thursday, 8:30 a.m. to 12:30 p.m. This will allow for around 50-60 people per day with an appointment.

Correspondence

Kent County is going to grind the brush pile one more time this year. They are proposing the Nicholson drop off center be used by the residents directly. Mayor Jacobs will talk to the County for their continued support. A discussion followed and will be discussed again at the next meeting.

Administrative Reports

Clerk-Treasurer Loller gave the financial report. (*)

Acting Police Chief Dempsey gave the police report. (*)

Mayor Jacobs stated that effective July 1, 2020 Acting Chief Dempsey was officially made Chief of Police. Mayor Jacobs said the promotion was well deserved.

Mayor Jacobs received a letter asking about the cameras at the beach. Chief Dempsey said they are within the law and the cameras are to secure the property and deter vandalism.

Streets and Sanitation

Will start opening the Visitor Center and cleaning it on a regular basis. Still having problems at the Village Restrooms with people trashing them. Will change locks to prevent this and will have the Police lock up the facilities at night.

Street repair quote from Brambles is \$6,700.00 for Boundary Avenue, West Sharp Street and Henry Avenue.

Dump Truck is out of service.

Delmarva Power to install 23 LED lights on Main Street.

A discussion on trash regulations for small businesses was held. Town Manager will talk to the trash contractor about this situation.

Water and Sewer Operations

Water and Sewer Plant monthly report attached.

Water plant is still running high, but the Sewer plant average flow has dropped from 10.7 million gallons down to 7.9 million gallons per month.

WWTP pump #1 is out for service because the seal and shaft are bad. Should be back up and running next week.

New pump at PS#7 has been replaced and is back up and running.

Town Manager Resele wanted to explain what happened on July 4th with the well. The events that caused discolored water in the past three weeks has to do with an aging water line infrastructure that is sensitive fluctuations in water pressure.

The discolored water issue was very obvious during the past weekend's low pressure from the well pump control failure. The other events were the use of our hydrants to fill a fire tanker which also caused a low-pressure condition in the system. With that being said we have done many things to help prevent discolored water such as.

- town wide flushing on a scheduled routine
- changing the process of adding chemicals
- new meter pumps

The new Clarifier is working as a primary filtering unit to help our aging filtration system and that system will be upgraded with a new project.

The number one reason for discolored water is the aging water line on the east side of the town. These water lines are greater than 50 years old. As we create the new projects to improve the water system, replacing these lines are top priority.

People need to understand what the town has is old operating facilities both in the water plant and sewer plant. The community is exposed to the ramifications of the water plant because they haven't been well maintained over the years. The Town has put money into them through Grants but there is still more work that needs to be done. The Town has a fragile water system that they are trying to keep going. The problem with the well 4R was the soft start failed. To fix that problem, Town Manager Resele requested the purchase of a VFD for \$8,899.00.

Vice Mayor Andrews made a motion to approve a purchase of a VFD for \$8,899.00. Councilmember Jones seconded the motion. All in favor. Motion carried.

Mayor Jacobs asked about the smell of chlorine in the water. Town Manager Resele and Councilmember Edwards told her that if you smell chlorine it means that is not enough chlorine in the system.





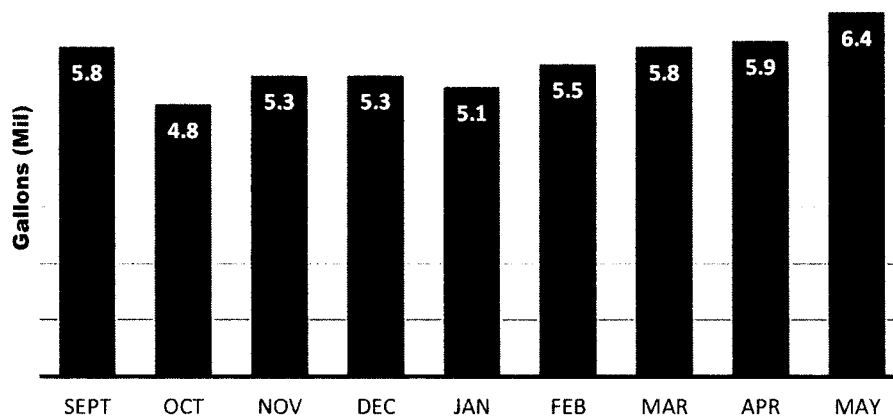

Water flow from Pumps

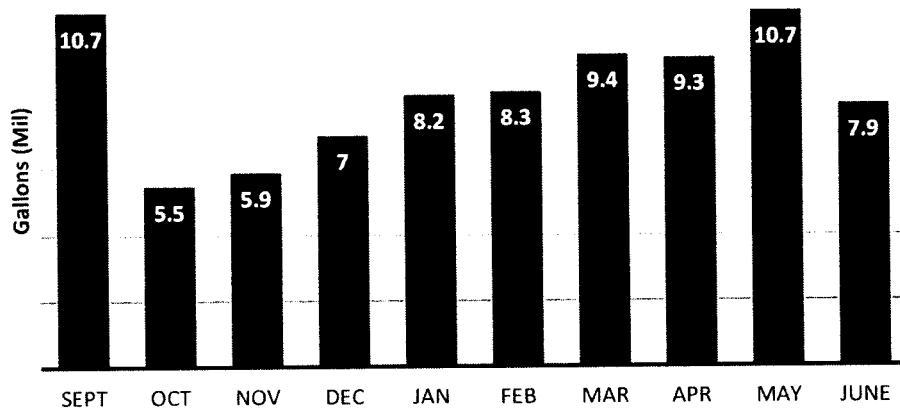
