Agenda

Variable Speed Drive (VSD) is ready to be installed for well #4

Still waiting on horizontal tank testing on the sand filter.

Will be looking for a quote on a 10-year water tank maintenance contract.

Town Manager Resele read the Sewer Plant Monthly report which is attached.

PS#2 needs valve replaced – still waiting on a quote,

PS#4 needs to be repaired – looking for quotes.

Still need more spare parts for all pump stations.

Vice Mayor Andrews made a motion to purchase the spare parts needed for pump station repairs as outlined in Town Managers report Councilmember Edwards seconded the motion. All in favor. Motion carried.

Parks & Recreation

Moved the dugouts to the water plant warehouse.

Talked to Donna Legg about Halloween and the P & R will try to plan something out.

Vice Mayor Andrews made a motion to spend \$3,500.00 to have MacLeod Law Group update a new Personnel Policy Manual for the Town. Councilmember Jones seconded the motion. All in favor. Motion carried.

Transportation Deposit Money

Need to find where the \$5,000.00 deposit money is for the Trolley and will request to have it returned. The Bus Company wants to make \$1,000.00 a month payment on the money.

The Fire Company wants to have Fireworks on Saturday, October 31, 2020. The President said they guaranteed people that donated that there would be fireworks this year. Town Manager Resele said they will need to file a Special Events Permit which has to be approved by the Council.
