# APPROVAL OF THE MINUTES:

Councilmember Kuechler made a motion to approve the minutes of the Regular Mayor and Council Meeting of May 14, 2009; Councilmember Price seconded. All in favor, motion carried.

# **CORRESPONDENCE:**

Mayor Jacobs read a Thank You post card received from the Kent County High School Band Boosters for donating to their trip to Hershey Park. An invitation was received from Cindy Genther of the Kent County Chamber of Commerce inviting all to a ribbon-cutting ceremony to be held July 3, 2009 at Harbor Woods.

# POLICE REPORT:

Lieutenant Officer Cliff Wilson read the report into record.

#### STREETS/SANITATION:

Councilmember Toulson had nothing to report.

### SEWER/WATER:

Councilmember Kuechler reported the Waste Water Treatment Plant treated 11,498,000 gallons and received 5.5" of rain during the month of May; the Water Plant treated 5,305,000 gallons and received 5.5" of rain during the month of May; Synagro hauled 6.5 loads of sludge.

#### PARKS/RECREATION:

Councilmember Willis reported the basketball courts will be seal coated and a contest at Rock Hall Middle School is on-going to design a logo for Parks and Recreation.

#### PLANNING/ZONING:

Councilmember Price reported at the June 10, 2009 meeting the board approved a business application for Mermaid of the Rock, LLC – a novelty and gift shop; Rock Hall Associates, representatives for Rock Hall Manor, were granted approval for remodeling but denied approval to add a playground area. Rock Hall Associates will donate the equivalent funds of a playground to the Rock Hall Parks and Recreation Board; Alice Ritchie, legal representative for the Rock Hall Board of Appeals, turned in her resignation, to be effective January 1, 2010.

#### MUSEUM BOARD:

Councilmember Kuechler reported on the meeting held June 11, 2009. The Rock Hall Museum received a \$300 donation from the Taste of Rock Hall and received \$119 in book sales and jar donations.

#### ORDINANCES/RESOLUTIONS:

Ordinance #2009-01, Identity Theft Prevention Program, was introduced by Mayor Jacobs at the May 14, 2009 meeting. After a brief summary of the ordinance given by Assistant Town Attorney Patrick Thomas, Councilmember Kuechler made a motion to adopt Ordinance #2009-01, Identity Theft Prevention Program; Councilmember Toulson seconded. All in favor, motion carried.

Resolution #2009-02, Endorsing a Housing Development to be Financed by the Maryland Department of Housing and Community Development, was introduced by Mayor Jacobs. Due to misleading wording in one paragraph, Mayor and Council asked Patrick Thomas to have the resolution revised. Voting will take place at the next meeting.
