MAYOR AND COUNCIL REGULAR MEETING MINUTES August 14, 2008

The Mayor convened the Mayor and Council Regular Meeting on the above date at 7:40 p.m. All Councilmembers were present with the exception of Councilmember Toulson. The Clerk-Treasurer and Chief of Police were present. The Town Manager and Town Attorney were absent.

APPROVAL OF THE MINUTES:

Councilmember Price made a motion to approve the minutes of the Regular Mayor and Council Meeting of July 10, 2008; Councilmember Willis seconded. All in favor, motion carried.

GUEST SPEAKER/INVITED GUESTS:

Amy Moredock (Kent County Planning Commission) spoke in reference to the Comprehensive Plan currently under development. She advised that grant money is available for several of the remaining planning stages at a sum of up to \$35,000. The Community Development Block Grant was initiated to help smaller municipalities that do not have the resources available to complete the Plan. A Public Hearing will be held on August 28, 2008 at 7:00 p.m. at the Municipal Building.

STREETS/SANITATION:

SEWER/WATER:

Due to a change in personnel, Councilmember Kuechler had nothing to report.

PARKS/RECREATION:

Councilmember Willis reported there was no July meeting. Councilmember Kuechler suggested asking a high school student that is a resident of the town to serve on the Board.

PLANNING/ZONING:

Councilmember Price reported on the Planning and Zoning meeting held the previous night, August 13, 2008. Town resident Cope Hubbard requested a lot line adjustment to reduce (3) parcels to (2) forty-five foot parcels on Chesapeake Avenue. The Board unanimously approved the lot line adjustment.
