## MINUTES - UTILITY COMMISSION MEETING October 4, 2010

## SEWER ALLOCATION REPORT:

The Town Manager read the sewer allocation report into the record. There was a decrease of \$300.00 in the SCIGL account due to a sewer hookup on Fithian Lane.

THE FOLLOWING ITEMS WERE DISCUSSED:

A request for a sewer credit from Robert E. Willis for billing account #E2-052 I located at 21141 Haven Road. The bill is in the amount of \$530.59. There have been no prior credits made to the account. The amount of the credit would be for the total amount of \$279.50, leaving a balance of \$251.09. Councilmember Price made a motion to grant the sewer credit in the amount of \$279.50, leaving a balance of \$251.09. Councilmember Toulson seconded the motion. All in favor, motion carried.

The Town Manager reported that there is another axel that needs to be replaced. The cost to replace the two axels is going to be approximately \$19,700.00. Keep in mind that this waste water treatment plant has been operating non stop for 18 years. It's eventually going to need repair work done from every day wear and tear. There will be the need to transfer funds from the pumping stations account to cover the additional cost, but there are funds there to cover the cost.

Councilmember Price mentioned the continuous complaints from the residents that live on Catholic Avenue and the problems they are having with rust in their water. There are a couple of things that could be done to fix this problem. The pipes could he acid washed to get the rust out and cleaned up. There is a company that can clean the pipes completely out and recoat them so they would be just like new pipes again. The Town Manager, Councilmember Price, and Councilmember Kuechler are going to check out the options available to have this fixed.

With there being no further business, Councilmember Price made a motion to adjourn at 8:03
