Councilmember Kuechler reported the following: in October, the Sewer Plant treated 6,622,000 gallons, received 7.15 inches of rain and Synagro hauled four truck loads of biosolids; the Water Plant treated 4,644,000 gallons and received 7.0 inches of rain.

## PARKS/RECREATION:

Councilmember Willis reported on upcoming Holiday events around town. Santa will arrive by boat on December 5, 2009 at 6:00 p.m. This year he will debark at the docks at Bayside Landing Park. The Movie Night held for the Elementary School children was a success; a Movie Night for Middle School children is in the works.
