Councilmember Kuechler reported the following: for the month of November, the Sewer Plant treated 8,685,000 gallons and received 5 inches of rain; the Water Plant treated 4,003,000 gallons and received 4.85 inches of rain.

# PARKS/RECREATION:

Due to the absence of Councilmember Willis, the report was read by Town Manager Fithian. Parks and Recreation has received \$2,482.50 - \$2,000 from the Rock Hall American Legion and \$482.50 from Ms. Betty Ann Glenn with the Drug Prevention Connection program. A logo contest was held for students at the Rock Hall Middle School and the winning logo was designed by Sawyer Cornelius. His logo message: "I have better things to do than alcohol, tobacco and drugs". A prize will be presented to Sawyer at a later date. "Parents Night Out" is planned for December 18th at the Municipal Building.

# MUSEUM BOARD:

Councilmember Kuechler reported on the Rock Hall Museum Board will Open House at the Rock Hall Museum located in the Municipal Building from 4:00 p.m. to 6:00 p.m. on December 5th.
