The Town Manager gave an overview of the sewer credit request for Mr. George T. Lees, III. Councilmember Nesspor made a motion to approve the sewer credit request of Mr. George T. Lees, III in the amount of \$655.20. Councilmember Price seconded. All in favor, motion carried.

The Town Manager gave an overview of the sewer credit request for Mr. Andrew Thurman. Councilmember Nesspor made a motion to approve the sewer credit request of Mr. Andrew Thurman in the amount of \$772.20. Councilmember Kuechler seconded. All in favor, motion carried.

The Town Manager gave an update on the Clarifier Project.

An Audience Member asked about the vacant Councilmember seat. The Mayor stated that they would address that during the workshop meeting next.
