January 22, 2020

## Agenda

A motion to go into a Close Session was made by Vice Mayor Andrews and seconded by Councilmember Edwards. All in favor. Motion carried.

# **Budget Adjustments**

A discussion on the Utility Fund budget adjustments was held and Vice Mayor Andrews made a motion to reallocate \$37,000.00 in various line items in the Utility Fund to the Capital Expenditure Fund Balance Reserve account. Councilmember Collyer seconded the motion. All in favor. Motion carried.

Discussion of potential General Fund budget adjustments was held. Review to be continued at Special Workshop meeting scheduled for January 30, 2020.

A motion to adjourn the Special Workshop Meeting was made by Councilmember Jones and seconded by Councilmember Collyer. All in favor. Motion carried. Meeting adjourned 8:35 p.m.
