REGULAR WORKSHOP MEETING MINUTES

November 30, 2020

Mayor Jacobs called the Regular Workshop meeting to order at 6:36 p.m. In attendance were Vice Mayor Andrews, Councilmember Jones, Councilmember Edwards, Councilmember Collyer, and Town Manager Resele.

Agenda

Councilmember Jones motioned to approve the agenda as presented. Vice Mayor Andrews seconded the motion. All in favor. Motion carried.

Minutes

Vice Mayor Andrews motioned to approve the Regular Workshop meeting minutes for November 2, 2020. Councilmember Collyer seconded the motion. All in favor. Motion carried.

COVID-19 Issues

As of the 30th there were 48 cases in the 21661-zip code area with a positivity rate of 5.42%. Kent County cases were 448 with a positivity rate at 6.86%.

CARES Funding

\$17,790.95 has been submitted so far but there was approval for extra items like Security Cameras, Microphone and Speakers for the Council Chambers, Plexiglass Window in the Clerk's Office and Hazard Pay through December 2020.

Annexation

There was a discussion with the Planning & Zoning Administrator Chris Jakubiak and he explained what Annexation meant to the Town if they decided to Annex the Bradley property.

Capt. Merrick Carter's Ark Boat - Fishing Shanty

Mayor Jacobs read a letter from Kate Johnson and the Council had a discussion on this matter. Lisa Sasser and Robin Kurowski addressed the Council about Captain Carter's Ark Boat and there was another discussion on who actually owns the Ark Boat. Mayor Jacobs suggested to table this until there is a Museum Board and have them reconsider Kate's offer. She stated there will be a Heritage Steering Committee meeting on Wednesday, December 16, 2020 and the first thing they will discuss will be forming a Museum Board.

Status of Special Events

The Crab Basket Christmas Tree Lighting will be held on Saturday, December 5, 2020 at Dr. Durocher's lot on Main Street.

Approval of Ordinance will be approved at the next M & C Regular Business Meeting on December 20, 2020.

The Town Manager read his report on the status of the following grants:


Next Meeting Dates
