

## **MAYOR & COUNCIL**

#### **UTILITIES BOARD MEETING MINUTES**

February 3, 2020

Mayor Jacobs called the meeting to order at 6:08 p.m. In attendance were Vice Mayor Andrews, Councilmember Edwards, Councilmember Collyer and Town Manager Robert Resele. Councilmember Jones was absent.

# Agenda

Vice Mayor Andrews motioned to approve the agenda as amended for February 3, 2020. Councilmember Edwards seconded the motion. All in favor. Motion carried.

#### **Minutes**

Vice Mayor Andrews motioned to approve the Utilities Board meeting minutes for December 30, 2019. Councilmember Edwards seconded the motion. All in favor. Motion carried.

# **Sewer Allocation Report**

Town Manager Robert Resele stated that there were no changes to the report from the previous month and that there were no new hook ups.

# **Sewer Credit Request**

A discussion was held about a credit for Waterman's Crab House. The Council denied the credit associated with the first calendar quarter of 2019 based on a study of past annual usage.

There was a discussion with the owner of the Trailer Park, and it was decided that the Council would approve a credit. Vice Mayor Andrews made a motion to approve a sewer credit of \$10,019.25 with a balance to be paid of \$6,421.98. Seconded by Councilmember Collyer. Mayor Jacobs and Councilmembers Andrews and Collyer were in favor. Councilmember Edwards was opposed. Motion carried.

Owners of Kent Street property sent in a request letter for sewer credit. It was decided to grant them a sewer credit. Their new bill will be \$409.74, and the matter will be settled.

Also, will require a minimum payment from the residents of Memory Lane to avoid shut-off.

# Water and Sewer Plant Updates

Town Manager Resale's report is attached for details.

Highlights -

The Council approved the changes to Haven Harbour South 2 inch and 6-inch water connections.

Kent County installed a new register on the meter in Edesville and is still not working properly. Need to set up meeting with the County to discuss a plan of action to get usage rates.

Henry Avenue has low water pressure which is on the Town's side of the meter. Plan to dig down and push a new line.

Chlorine Feed system is now up and running with no interruptions to the water system.

#### **Wastewater Treatment Plant**

PS# 3 - is out for repair for a worn shaft.

PS# 8 - is investigating alarms.

New Sludge hauler ready to start removal this week. Tipping fee will be billing directly to the Town.

## **Utilities Projects**

ENR Grant – Submitted the application for SRF loan portion.

Water Meter and Project – GMB has submitted their proposal to MDE. Estimated completion date by June 2021.

Water Plant Filter Solution – GMB to be asked to evaluate as a Miscellaneous On-Call Engineer Task.

SERCAP Utility Rate Study – Mayor Jacobs, Town Manager Resele and Town Clerk-Treasurer Loller had a conference call meeting with Jean Hollowell of SERCAP to review her updated analysis of data for the Utility Rate study SERCAP was developing. The Mayor recommended that the study be tabled until 2021 when the automated meter project is expected to be completed and as a result more accurate data on usage will be available. Council agreed to table the study.

KCWS Agreement – No new action to report. Meter at black smith shop still not functioning correctly. Mayor Jacobs asked that the cost to place a meter where originally intended on Rt 20 at end of the Wesley Chapel line be solicited from prospective contractors.

2017 USDA - Financial settlement of USDA water improvement project is still pending response from McCrone on replacement of flow valve in new well.

Next Utility Board Meeting will be held on Monday, March 2, 2020.

Councilmember Edwards made a motion to adjourn the Utility Board Meeting. Councilmember Collyer seconded the motion. All in favor. Motion carried. Meeting adjourned at 7:35 p.m.
