UTILITIES BOARD MEETING MINUTES

January 31, 2022

Town Manager Robert Resele stated that there were no changes to the report from the previous month and that there were no new hook ups.

Water Plant Operations Update

Now running Well #5.

Delivery of Chemicals two weeks late – supply issue.

ProStart to install and train on recording software – Fastware January 13, 2022.

Pump Station Updates

Pump Station #2 not in operation – running with portable pump.

GMB to evaluate for Grant Funding.

DSi to temporary set up to run one pump – one or two weeks.

Since PS#2 is not working, Mayor Jacobs made some phone calls looking for emergency funding from the State. It was suggested to go ahead and start the project to replace all nine (9) Pump Stations with MDE. The application for funding was due on Monday, January 30, 2022. Mayor Jacobs reached out and got a one (1) week extension. There was a discussion and it was decided that there will be one (1) application for PS#2 because it is an emergency and another application for the other eight (8) to be upgraded.

Haven Road Water Main Replacement

There was a discussion.

Councilmember Cook made a motion to allow Mayor Jacobs to sign the plans in conjunction with the Water Main Replacement on Haven Road. Councilmember Edwards seconded the motion. All present in favor. Motion carried.
